## **Community-Based Pharmacy Residency Program (PGY1)**

### **Bayamón, Puerto Rico**

The University of Puerto Rico Community-Based Pharmacy Residency Program has one position available for one resident in partnership with **Farmacia Santa Cruz Pharma Care, Bayamón, P.R.** The program is financially supported by **Farmacia Santa Cruz Pharma Care** and academically affiliated with partial financial support by the **University of Puerto Rico School of Pharmacy**. The residency provides a postgraduate training opportunity for pharmacists to enhance their skill set in the community pharmacy setting by providing a variety of patient care services. Pharmacists in this setting will have a direct influence on patient outcomes through participation in medication reconciliation, transitions of care, patient counseling, immunization services, medication therapy management with a specific emphasis on patient adherence and disease management, and compounding pharmacy services. Residents will also work to develop collaborations with other health care providers to improve the health care in our communities. The residency program graduates will be leaders in the pharmacy community and will have an active role in advancing community pharmacy practice.
