Overview of the IRB Protocol & Committee Modules

Streamlyne's IRB Protocol & Committee Modules are designed to facilitate the institutional processes that ensure compliance with the federally-mandated protection of human subjects participating in research activities. Principal Investigators initiate and submit IRB protocols, amendments, and renewals within the system. Protocols are automatically routed to the appropriate departments and corresponding IRBs for review and approval. Reviewers and Committee Members have access to the protocols online where their comments and decisions are preserved. IRB administrators have all the tools they need to track protocols, coordinate reviews, manage committee meetings, maintain associated correspondence, and properly administer protocols throughout their lifecycles.

Using This Guide

Please keep the following things in mind as you use this guide:

A Stepwise Approach

These guides are designed to facilitate immediate productivity for new users in a complex and unfamiliar system. To achieve this end, the processes are broken down into manageable sections with the steps to each process laid out sequentially.

By practicing the steps and experimenting in the application at the detail level, you will gain the knowledge you need to master your role or design high-level processes that meet your institution's unique needs.

Navigation and Common Elements

This guide assumes you are familiar with the common features and basic navigation as presented in the **NEW USER MANUAL: Navigation, the Action List, and Common Document Elements.** Please use that manual as a companion to this one, as we have tried to eliminate redundancy wherever possible.

Every Installation Is Different

Streamlyne Research is highly configurable. If you are currently in the implementation process, it is likely your institution will perform some level of analysis to identify which features you would like to use, which values you would like to change to reflect your institution's terminology, and which features you will skip altogether.

Given this, the processes detailed in this document are representative of general IRB practices and do not necessarily represent the exact manner in which your institution will choose to use the application.

Let's begin!

Searching with IRB Lookups

To assist you in locating IRB Protocols and Committees within Streamlyne Research, IRB search windows, called lookups, are available from the Main Menu. Access to these lookups depends on the IRB roles assigned to you in your Person record, or user profile. Most users at an institution will have the necessary permissions to prepare and submit a protocol, while only IRB administrators will have access to the various administrative functions related to IRB protocols and committees. Some users (such as Department Chairs or IRB Committee Members) may also be involved in approving or reviewing protocols. See <u>Appendix A: IRB Roles and Permissions</u> for a complete list.

To search for items using IRB lookups, simply navigate from the Main Menu to the corresponding IRB Lookup as indicated below. Results will be displayed at the bottom of the page. If you wish to refine these results, enter further criteria in the Lookup fields and click the Search button.

All My Protocols

This lookup will generate a list of all the protocols you have ever submitted and any protocols where you are listed as personnel, regardless of the document status. If you are not the Principal Investigator or do not have permissions to edit the document, you will only be able to view the protocol document.

All My Reviews

Navigation Main Menu > IRB > IRB Lookups > All My Reviews

This lookup is useful to those who are regularly assigned to review IRB protocol documents. When you access this option, the system will automatically return a list of all the protocol documents currently assigned to you as a Reviewer.

All My Schedules

Navigation	Main Menu > IRB > IRB Lookups > All My Schedules

This lookup is useful to IRB Committee members who regularly attend Committee meetings. The results will show a schedule of meetings where your attendance is expected based on your Committee membership status.

This IRB Administrator lookup will generate a list of protocol submissions for approval, amendment, renewal, notifications, action requests, and acknowledgements in various statuses.

This lookup will generate a list of protocols that are in various statuses pending approval. The search results will include any protocols where you are listed as personnel. If you are not the Principal Investigator or do not have permissions to edit the document, you will only be able to view the protocol document.

Protocols Pending PI Action

This lookup will generate a list of protocols that are pending action from the Principal Investigator. Typically, these are protocols that have been returned to the PI for revisions. The search results will include any protocols where you are listed as personnel. If you are not the Principal Investigator or do not have permissions to edit the document, you will only be able to view the protocol document.

Protocols Pending Committee Action

Navigation

Main Menu > IRB > IRB Lookups > Protocols Pending Committee Action

This lookup will generate a list of protocols that have been submitted and are awaiting Committee review and approval. The search results will include any protocols where the user is listed as personnel. If you are not the Principal Investigator or do not have permissions to edit the document, you will only be able to view the protocol document.

Protocol Online Review

Navigation	Main Menu > IRB > IRB Lookups > Protocol Online Review

This IRB Administrator lookup allows the administrator to search and view a list of all assigned reviews in order to capture the review status and further manage the review process. The system will default to a review status of Saved but the status can be changed to display results of reviews in a Final status or a Cancelled status.

IRB Committee Schedules

This IRB Administrator lookup gives the administrator quick access to a list of the Committee schedules without having to access the schedule through the IRB Committee Document.

Initiating & Submitting a New Protocol

This section will describe the steps to initiate and submit a new IRB Protocol document in Streamlyne Research. Principal Investigators, other researchers or their support staff typically initiate and submit these documents. If you will be initiating or submitting IRB protocols, use this section to begin using the IRB module productively.

If your role does not require you to initiate or submit IRB protocols, use this section to familiarize yourself with the entire process in order to effectively edit, review, approve or administer documents as they are routed to you.

For a flowchart of the standard lifecycle of a protocol, see <u>Appendix B: IRB Protocol Workflow</u> <u>Overview</u>.

Initiating a New IRB Protocol

If your goal is to quickly initiate and save a protocol for later editing, be sure to have the following information available, as these 5 fields must be completed for the document to save without validation errors:

To quickly initiate and save a Protocol, follow these steps:

- Initiate a new document by following the navigation path here, as above:
 Main Menu > IRB > IRB Protocol > +
- 2. Complete the Minimum Required Fields for Saving detailed in the preceding table.
- 3. Click the Save button.
- **Result** A protocol number is automatically assigned.
- **Note** Once the document is saved, it will remain on your Action List as a pending item with a COM symbol, prompting you to complete the document at your convenience.

The protocol will remain on your Action List as a COM pending item until you submit it, delete it, or withdraw it.

Access the IRB Protocol again by clicking on the corresponding Id hyperlink next the COM item on your Action List.

Updating the Protocol Tab

If you have just initiated and saved a new protocol, simply continue updates in the open Protocol tab.

Otherwise, initiate a new document by navigating as follows:

1. The **Protocol Type** is used to designate the level of IRB review required. The types as well as the default value are configurable by your institution.

Click the arrow next to the **Protocol Type** field, and then select the appropriate option from the dropdown list.

- 2. Look up the internal or external user serving as **Principal Investigator** by clicking the magnifying glass ^Q to search for and select return value of the desired record.
- 3. Enter a descriptive title for the project in the **Title** field.
- 4. The Lead Unit defaults to the unit assigned to the Principal Investigator.

If this is not the correct department for the project, enter the Unit Number into the **Lead Unit** field. If necessary, use the dropdown to select the correct value. Only Units associated with the PI and/or the protocol Initiator will be offered.



- 5. Click the Save button. Save
- **Result** Streamlyne Research will generate a Protocol Number that will display in both the Document Header and the Status & Dates section. The protocol number is ten digits in length. The first two digits represent the year of the creation date, the next two digits represent the month of the creation date, and the remaining six digits are assigned sequentially, as follows: YYMM123456.

The Initiator and Last Updated timestamp will be updated in the Document Header as well:

These identifiers will not apply to every protocol.

If this project has a protocol number with an external IRB or an external research network, capture the entity, the identifier, and associated dates in this section. This will not apply to every protocol.

- If this project is associated with an external research network or external IRB, click the arrow next to the **Type** field and select the corresponding acronym from the dropdown list. Some examples of common networks that IRBs can work withare:

Protocol Tab > Organizations

The Organizations section allows you to indicate which, if any, outside institutions may be performing some aspect of the study activities. Organizations that are configured in the system have identified contacts, called IRB Correspondents, who may be listed on the Personnel Tab and are eligible to receive autogenerated, email correspondence as the protocol moves through its lifecycle. Organization profiles are configured and maintained from

Main Menu > Settings> Organizations.

Access to create, update, or inactivate Organization profiles is governed by a role assigned to the user's Person record.

- 2. Enter the **Organization ID** or click the magnifying glass ^Q to search for and select return value of the corresponding organization.
- 3. Click the arrow next to the **Organization Type** field to identify this organization as the organization performing the research, an external organization, or the single IRB of Record (sIRB).
- 4. Click the Add button to complete the action.
- 5. Repeat Steps 2 through 4 until all collaborating institutions are included on the protocol document.

Protocol Tab > Funding Sources

The Funding Sources section internally links the protocol to one or more proposals, awards, or departments within Streamlyne Research.

Note If your institution is using the Streamlyne Research Pre-Award and/or Post-Award suites, the **Funding Number** field dynamically integrates to these modules greatly facilitating congruency checks.

If you selected a Funding Type of Development Proposal, Institutional Proposal, or Award, Streamlyne Research will prompt you to link the specific document to the Protocol using the magnifying glass next to the **Funding Number** field to search for and select the desired value.

If your funding is coming directly from a Sponsor or a Department/Unit within your institution, Streamlyne Research will prompt you to identify the Sponsor or Unit instead of a Funding Number.

Entering this information will also display the Proposal, Institutional Proposal, and/or Award on the Streams page for easy access between different administrators who need to view the linked documents (if permissions allow).

- 3. Enter a Funding Number or click the magnifying glass ^Q to search for and select the corresponding return value.
- 4. Click the Add button to complete this action. Add
- 5. Repeat Steps 2 through 4 until all Funding Sources are identified.





The Questionnaire functionality in Streamlyne Research allows your institution to interview Principal Investigators and collect additional required information at the time of submission. This feature is very customizable and your institution has configured questions to match internal processes. The content within this function is, thus, unique to each institution. The particular questions presented to the user are also dependent on the Protocol Type selected in the Protocol tab. The sample screenshots below will familiarize you with the purpose and function of the Questionnaire tab but will not match your institution's application. Please consult with your local IRB administrator for details.

- 4. Click the More Information button to the right of each question to review any Explanation, Policy or Regulation references where pertinent.
- 5. Click the Save button at any time to save your work.
- The Questionnaire status will change to Complete once all questions are answered.



If the questionnaire is required, you will not be able to submit your protocol until all questions are answered and the Complete status displays.

As the name implies this section contains customized fields tailored to your institution.

Updating the Special Review Tab

The Special Review functionality is designed to record other reviews or administrative efforts linked to your IRB protocol in such instances as:

- Data sharing between projects that are tracked on separate IRB protocol documents.
- Project-related animal research protocols that are tracked on IACUC protocol documents.
- Technology/data protections for your project that are recorded on Intellectual Property Review documents.
- Biosafety and/or Environmental Health & Safety reviews
- Research-related facilities requests or clearances for your projects, such as space requests, lab transfers or material handling requests.
- **Note** If you add an IRB or IACUC protocol that is also maintained in Streamlyne Research, these protocols will also show up in Streams for easy access between different users and administrators, per their permissions.

All Special Review Types are determined by your institution.

Your institution may also elect to configure Streamlyne to automatically notify people or groups of Special Reviews when the protocol is submitted.

Updating the Permissions Tab

The Permissions tab contains read-only user role and project role data for the personnel identified in the previous sections. For example, the protocol's default Aggregators (or editors) will be identified as the Principal Investigator and the Initiator (if different from the PI).

An Initiator or IRB Administrator can also grant access to ad hoc users who might not normally have access to protocol documents. This is especially useful to a researcher who would like to turn over Aggregating (editing) Rights to a coworker in an administrative support role. This feature is also commonly used to grant ad hoc Viewer Rights to users who do not normally have access to protocols.





When a new protocol is complete, the Request an Action options available on the Protocol Actions tab include submitting the protocol for review or deleting the protocol. 

Submitting the Protocol Document to the IRB

Follow these steps to submit your protocol to the IRB. This submission action will enter the document into your institution's predefined workflow. Workflow stops, called nodes, generally begin with departmental and institutional approvals. This workflow is predefined by your institution and can vary from department to department. Once these approvals are in place, the workflow continues to the IRB Office for administrative review followed by Committee review (if applicable) and final approval before research activities can begin. You can access the workflow status at any time via the Route Log.

Recalling a Protocol

Withdrawing a Protocol

If you have submitted an IRB protocol that has reached the IRB Administrator for review and approval, but you no longer wish to have it reviewed, you can use the Withdraw action to stop the approval and review process. Once the review process has begun, however, only the IRB Administrator will be able to withdraw the protocol.

Editing a Returned Protocol

Sometimes a protocol is returned to the Principal Investigator by an IRB Administrator because it is incomplete, contains errors, or needs revisions based on committee feedback. Generally, a protocol is returned at two specific points in the process:

- When an institution has pre-review procedures in place to vet protocols before assigning protocol reviews to committee members;
- After formal review, when either a committee member or the full committee request specific minor or substantive revisions before approval can be granted.

The information available to the Principal Investigator and the manner in which he or she accesses the protocol document is influenced by the action taken by the administrator to return the protocol. This section will describe the scenarios in which a protocol could be returned.

Accessing a Protocol Returned Before Committee Review

This first scenario occurs when an IRB Administrator sends the protocol document back to the Pl using the Return to Pl Action, as described in <u>Returning the Protocol to the Pl</u>. This option is only available before any type of formal review has occurred.

Follow these steps when the title of the FYI Notification reads "Protocol Returned to PI Action," as shown in the image here:

- When a protocol is returned to the PI through the Return to PI Action, Streamlyne Research will send two items to your Action List: An FYI Notification and a COM Notification, indicating the document requires completion.
- 2. You can access the protocol by clicking on the hyperlink within the message body of the FYI Notification, however the quickest way to access the protocol is by clicking the hyperlinked document number in the ID column of the COM item.

Accessing a Protocol Formally Returned for Revisions


This second scenario occurs when an IRB Administrator sends the protocol document back after at least one committee member has determined that the study cannot be approved as it is currently

documented. More specifically, this occurs when one or more committee members records a determination of Specific Minor Revisions or Substantive Revisions Required.

Follow these steps when the title of the FYI Notification reads Substantive revisions requested or Specific minor revisions requested as shown in the image below:



- 1. When revisions are specifically requested, Streamlyne Research will send two items to your Action List: an FYI Notification and a COM Notification, indicating the document requires completion.
- 2. Click the Show button to open the FYI Notification.



3. Based on your institutional configuration, Streamlyne Research may generate a Correspondence Letter each time a formal determination is recorded for a protocol. The purpose of the letter is to formally document and communicate the reason for the determination.

Click the view correspondence hyperlink in the body of the message, if appropriate.

- **4.** You may then review the reason for the determination as documented in the Correspondence.
- 5. If you choose, you may download and save the PDF for your records.
- **Note** The correspondence is also stored within the protocol document. See <u>Accessing</u> <u>Correspondence</u> for more information.







Understanding Streamlyne Amendments & Renewals

Amendment

Streamlyne allows an approved protocol to be amended at any time. The purpose of the amendment is to notify the IRB of any changes to a previously approved human subjects study.

Renewal

Streamlyne allows an approved protocol to be renewed at any time. The purpose of the renewal is to garner the IRB's approval to extend the study beyond the current expiration date. Streamlyne allows for both Renewals and Renewals with Amendments, as it may be necessary to amend the approved human subjects study at renewal time.

Starting from a Copy

When user initiates an Amendment or Renewal, Streamlyne creates the document by copying the original protocol content into a new version.

Streamlyne will identify the source of the copy in the Document Header, as shown above in the **Copied from Document Header ID** field.

Differences in Naming Convention

Streamlyne identifies Renewals and Amendments by appending unique identifiers to the original protocol number, following the format RNNN or ANNN respectively. For example, the Protocol # above of 1802003135A001 indicates this is the first amendment submitted for Protocol #1802003135.

Merging Amendments and Renewals

After the review process is complete, and the amendment or renewal is approved, the system versions the original protocol and merges the new information into the original document.

Streamlyne updates the Document Status to either Amendment Incorporated into Protocol or Renewal Incorporated into Protocol.

Using the Summary & History Section

When the amendment or renewal is first submitted, you can access the entire history of the project by navigating to Protocol Actions > Summary & History.

For Amendments, the system will display the Amendment Details section, which contains a **Summary** of changes as marked sections to indicate where changes were made.

For Renewals, the system will display the Renewal Details section, which contains only the **Summary** of progress to date.



Communicating with the IRB

Streamlyne delivers a number of features to facilitate communication from the study team to the IRB regarding any study activity.

The benefit to leveraging these features is that all communication will be captured in the Summary and History sections of the protocol.

This chapter will review the purpose of each of these features, and provides the steps to execute each.

Notifying the IRB

This process applies to all instances in which the PI needs to notify the IRB Committee of an event that occurred that may require further review or scrutiny by an IRB Administrator and/or IRB Committee. The most common occurrences are adverse events, unanticipated problems or protocol deviations. However, there are a variety of events that may be applicable. Not all will be covered in this manual, but the steps to submit a Notify IRB action are the same.

Access the protocol through IRB Actions > Notify the IRB on a Protocol. Clicking this menu option will display all the protocols that qualify for this action.

- 1. Locate the protocol that you would like to notify the IRB about.
- 2. Click the perform action hyperlink on the corresponding row.
- **Result** This will open the protocol on the Protocol Actions > Request an Action > Available Actions subsection.
- **Note** You may alternatively navigate to Protocol Actions > Request an Action > Available Actions subsection, if you are already in the protocol for which you would like to take action.
- 3. Under Available Actions, the Notify IRB section will display.

Requesting to Close a Protocol

Your institution may require PI's to formally close protocols once the research is complete, is no longer being executed, or the PI is transferring to a different institution.

III: For Departmental Reviewers & Approvers

Based on your institution's specific Policies & Procedures, Principal Investigators, Department Chairs, College Deans, administrators, or other institutional officials may be required to approve IRB protocols and IRB-related requests in a hierarchy prior to final submission to the IRB. To facilitate this process, Streamlyne Research routes submitted protocol documents and requests to the appropriate Action Lists of those specified in your institution's IRB workflow configuration for review and approval.

A typical approval progression might route a protocol from the Department Administrator to the PI, the Department Chair, and perhaps even to the Dean before an IRB Administrator will take action on the protocol. Amendments, renewals, and IRB requests could follow the same workflow route or it may be different, depending on your institution's internal business practices. The steps to complete a review and approval in workflow remain the same regardless of the submission type.

Departmental reviews are configurable and optional. If you institution has chosen to route submitted protocols through Chairs and Deans, follow the steps included in this section to complete those reviews.

Completing IRB Committee Reviews

Based on your institution's specific Policies & Procedures, IRB Committee Members may be assigned to review and comment on assigned protocols, approve exempt or expedited protocols online, and/or attend scheduled committee meetings to approve protocols.

Some institutions will assign a select number of IRB Members to review and comment on certain protocols prior to the committee meeting. To facilitate this function, Streamlyne Research makes a new Online Review tab available within these protocols for both reviewers and administrators. Once the IRB Administrator completes the Assign Reviewers action, the protocol becomes available to the selected committee Members. For IRB protocols that will not go on to a Full Board Committee Review, such as Exempt or Expedited protocols, this Online Review step is the point at which the committee members can render an official decision.

Completing an Assigned Online Review

A committee member should complete this process upon receiving a Review Assignment from the IRB Administrator. This required assignment will appear on the committee member's Action List as shown:



Viewing Previous Review Information

Often the assigned reviewer is reviewing a protocol that has already been reviewed by themselves or a different member of their committee. Prior to a re-review, it is helpful to view previous determinations, comments, or the official correspondence outlining the changes that were needed. These comments can be viewed a few different ways: Quick Steps:

- Access the official correspondence letter by going to Protocol Actions > Summary & History > History and viewing the section that corresponds with the last Return for Revisions action.
- 2. Access the Reviewer information and comments by going to Protocol Actions > Summary & History > Reviews and Attachments.

Note: Only Final Review comments will be visible unless made by the reviewer currently assigned.

Preparing for Committee Meetings

Once the IRB Administrator has sent an agenda, members of the committee will receive a notification indicating that meeting agenda has been created. They will be able to access both the PDF version of the agenda as well as an interactive Meeting page. It is on this Meeting page that they will be able to access the protocols that will be reviewed at the meeting. Only specifically-assigned reviewers will be able to make official review comments via the Online Review functionality.

Streamlyne Research provides robust administrative functionality to support the protocol's path through the administrative and IRB committee review process. Generally, a user would not use these administrative features until after all departmental and institutional approvals were in place. Such a user would need the IRB Administrator role assigned to their profile to take advantage of these features.

Many of these actions are called different things but require similar steps within the system. A complete listing of all actions is contained in <u>Appendix C:</u> <u>All Protocol Actions</u>. 

Assigning an IRB Committee and Meeting Date

The Modify Submission Request action is used to allow the IRB Administrator to assign a committee (for Full Board and Expedited protocols) and a schedule date, as well as to correct the Submission Review Type if needed. Assigning a committee and choosing a schedule date is a prerequisite to most other administrative functions that are available with the exception of Exempt protocols.

Administering Online Reviews

Based on your institution's specific Policies & Procedures, IRB Committee Members may be assigned to review and comment on assigned protocols, approve exempt or expedited protocols online, or attend scheduled committee meetings to approve protocols.

Some institutions will assign a select number of IRB Members to review and comment on certain protocols prior to the committee meeting. To facilitate this function, Streamlyne Research makes a new Online Review tab available within these protocols for both reviewers and administrators. Once the IRB Administrator completes the Assign Reviewers action, the protocol becomes available to the selected committee Members. While each reviewer (committee member) can only access their own individual review from the Online Review tab, the IRB Administrator can access and manage all the assigned reviews through this same tab.

For IRB protocols that will not go on to a Full Board Committee Review, such as Exempt or Expedited protocols, this Online Review step is the point at which the committee members can render an official decision.

Additionally, an IRB Administrator can manage committee member reviews using the Accept, Return, or Delete Review Comments actions once reviews are complete. For more information, you may reference <u>Appendix C: All Protocol Actions</u>.

Assigning Reviewers to a Protocol

Once the protocol has been assigned to a committee, the system makes the document available for the IRB Administrator to Assign Reviewers. Reviewers are members of the committee you selected when you assigned the protocol to a committee (<u>Assigning an IRB Committee and Meeting Date</u>).

Managing Review Comments & Attachments

The IRB Administrator has access to add, update, restrict, and finalize comments and attachments using the actions described in this section. These comments and attachments can be added at various times during the review process:

- During pre-review by the IRB Office staff
- By online reviewers once they have been assigned
- By an administrator during the committee review process.

Returning and Accepting Review Comments

After an assigned reviewer has completed and approved their review of the comments, the IRB Administrator will receive an FYI notification indicating that the review is complete. In addition, the APP button for that particular review will remain on the IRB Administrator's Action List until they accept the review to finalize it. This final step integrates the review comments into correspondences and official meeting minutes.

Take these steps to Return or Accept the assigned review.

- Deleting the review
- Returning the review to the assigned reviewer for further changes
- Updating the private and/or final settings

Approving an Online Review

As each assigned reviewer completes his or her assigned review, the system aggregates the details of each completed review onto the IRB Administrator's Online Review tab within the protocol document.

Granting an Exemption

Exemptions are granted to studies where the research poses no risk whatsoever to human subjects. In some cases, IRB protocols with Submission Types of Exempt are created simply because the sponsor requires the project to be registered with the IRB. In addition, revised Common Rule regulations allow for Exemptions to be granted without committee member review and therefore can be registered by an IRB Administrator as soon as the protocol is received in workflow.

Deferring a Protocol

The IRB Administrator may want to defer review of a protocol if there is not enough information to make a decision about a protocol. There are a variety of reasons why this may happen: comments/revision requests have been sent to an investigator, but a response was not provided by the time of an IRB meeting; a protocol was tabled at an IRB meeting and put on the agenda for a subsequent meeting, but the investigator was not able to provide revisions by the time of the meeting, so the protocol review was deferred to another subsequent meeting.

Using this action, the IRB Administrator can move a protocol that has been submitted for a committee review to either a different committee or a different schedule for the same committee.

 From the Protocol Actions tab, click the section header to expand the Request an Action section. In some cases, this section may appear expanded by default.

Preparing and Generating Committee Meeting Agendas

In addition to reviewing protocols, IRB meetings often entail other pieces of business that need to be discussed with members. The IRB Meeting page contains five sections:

- Meeting Details
- Protocol Submitted
- Other Actions
- Attendance
- Minutes

Each allows for the entry, selection, and/or viewing of information pertaining to a particular meeting. Information included on an Agenda will be pulled from this page. It is important to enter the information here before generating the agenda.

This section describes the steps to finalize and disseminate a Meeting Agenda. This step is taken after all protocols to be reviewed at the meeting are assigned to the meeting date for this particular agenda.

Batch Correspondence

IRB Batch Correspondence functionality provides a means for institutions to configure automated reminder notifications to go out to researchers to remind them on a timely basis of certain actions they need to take related to their protocols. These reminder notifications are triggered manually by a designated IRB staff member and are done so based on the institutions standard operating procedures. Streamlyne Research provides Batch Correspondence functionality for the following two scenarios.

- Protocol Renewal Reminders Batch correspondences related to renewal reminders serve to remind researchers when they need to renew their protocol because their protocol's expiration date is approaching.
- **Reminder to IRB Notifications** Batch correspondences related to Reminder to IRB notifications remind researchers to revise and re-submit their protocols when it has been returned for revisions (Specific Minor Revisions or Substantive Revisions Required).

Batch Correspondences are sent out based on committee first and then protocols that are either expiring or need resubmission based on that committee.

In addition to generating reminders for the researcher, the Batch Correspondence also allows institutions to set up a final action to be taken on the protocol by the system at the time of the final reminder. The most common examples are expiring a protocol after the final renewal reminder or withdrawing a protocol after the final reminder to IRB Notification.

Note that the final decision cannot be recorded unless the protocol has been assigned to a meeting agenda. Refer to <u>Assigning a Protocol to a Meeting Agenda</u> if you missed this step.

Entering Attendance Information

Before committee decisions can be recorded for the specific protocols reviewed, the IRB Administrator must update the Meeting page with attendance information. This information includes both voting and non-voting members present.

The total number of those who were present and voting must match the total number of votes recorded when entering the committee decision within each specific protocol.

Closing a Meeting Record

The IRB Administrator can log additional meeting details after the meeting has occurred. This is in addition to recording the Attendance information discussed in <u>Entering Attendance Information</u>.

Recording Meeting Minutes



Meeting Actions

Administering & Maintaining Active Protocols

The full lifecycle of a protocol after initial approval varies greatly.

For the major transactions such as amendments and renewals, Streamlyne Research handles the IRB submission, administration and committee review processes much like the steps taken for initial submissions and reviews.

For example, when an amendment is submitted for an expedited protocol, the amendment will get assigned to a committee and then to a reviewer from that committee, as needed. Whereas, an amendment that qualifies for Full Committee review will need to be assigned to an agenda and reviewed at a convened meeting. The same goes for renewals.

This section will not cover the step-by-step process of managing the review process of amendments and renewals as they have already been covered. This section will cover various other important actions that the IRB Administrator may facilitate over the lifecycle of an IRB protocol.

These administrator level actions are all found under the Available Actions within the Protocol Actions page.

Reviewing and Acknowledging a Notify IRB Action

The <u>Notify IRB Action</u> is used by the Principal Investigator to inform the IRB of an event or provide new information about the protocol that does not require an amendment. This is an umbrella action that encompasses things such as adverse events, unanticipated problems, protocol deviations, and other events or transactions that a Principal Investigator or study team member may want to notify their IRB about for review and acknowledgment.

This action can be escalated to a committee member for review (Assign Reviewer) or can be included on an Agenda (Assign to Agenda) for review at a convened committee meeting.

1. Once the Notify IRB Action is taken by the Principal Investigator, the IRB Administrator will receive an FYI Notification as well as an ACK Notification in their Action List.







Appendix D: Editing Correspondences

The purpose of this section is to educate the user on how to perform basic edits to Protocol Correspondence templates.

Protocol Correspondences are generated by taking an XML representation of the protocol data and merging it with an XSL Template via a process called XSL Translation. Modifying the appearance and some of the static content of the correspondences is achieved by editing the XSL Template. These XSL Templates describe the layout of the final correspondence along with some of the static content.

Understanding XML Basics

XSL is very similar to HTML in its syntax and layout. An XSL document consists of a series of nested tags. Each tag is a word or words surrounded by '<' and '>'. All tags appear either in pairs or as single, freestanding tags. For pairs, the second or closing tag is the same as the opening tag with the addition of a '/' character at the beginning of the tag. For single tags, the closing '>' is preceded by a '/'. Tags of the first kind (pairs) may contain data and other tags nested between the opening and closing tags.

Some tags also contain attributes contained within the tag. In the case of a pair of tags, these attributes only appear in the opening tag. They appear as key-value pairs expressed as follows: key="value". These often include layout data such as dimensions or styles.

Understanding Correspondence Template Layouts

Note: All examples in this document come from the default Approval Letter template.

All of the delivered correspondence templates begin with a brief layout section describing a body, named "xsl-region-body"; a header, named "xsl-region-before"; and a footer, named "xsl-region-after"; as shown here:

This section is followed by the main template. This main template is divided into two (2) static blocks, delineated by the tag "<fo:static-content>", and a third, longer section delineated by the tag "<fo:flow>". The static sections further define the header and footer while the third section is the main content of the correspondence.

Generally speaking, the first half of the correspondence section creates the headers of the correspondence such as the "To" and "From" lines. Protocol data is included here as well. These items are formatted using "<fo:table-row>" tags which are analogous to "" HTML. If you wish to remove any of these items from the table, be sure to remove everything between and including the "<fo:table-row>" tag pair.

In the following excerpt, for example, in order to remove the "Action Date" from the correspondence, you would remove everything between and including the highlighted lines:

Beyond these correspondence header sections are the sections that define the actual textual contents of the Correspondence. In many cases, the text of a correspondence is different based on an attribute of the protocol such as SubmissionTypeCode. These different sections are all contained within an "<xsl:choose>" block and each different choice is separated out within that block in "<xsl:when>" blocks. Sometimes a final "<xsl:otherwise>" block is defined as a case when none of the when blocks are selected. The text within these normally appears as formatted plain-text and can be edited directly.

Beneath this section is a section containing public comment entries and another that lists personnel on the protocol.

Finally, there is a large section at the end that contains what appears to be random text. This block of text contains the encoded version of the header image and should not be edited by hand.
