The PR-UCEDD in numbers

This report describes the progress of the PR-UCEDD activities during fiscal year 2020-2021. During this period, the PR-UCEDD faculty and staff participated, promoted and/or collaborated in the following activities:

Provided training to students of several disciplines including Social Work, Education, Nutrition, Occupational Therapy, and Speech Pathology:

Training to professionals and Technical Assistance

- To 455 professionals with Continuing Education credits to increase their knowledge about topics related to the population with developmental disabilities, violence prevention and long term

Dissemination of Information

- 1,961 brochures on DD-related topics were distributed.
- 592 informative capsules/educational material about COVID-19 and training promotions through the Facebook page were published for a total of 3,346 products.

Highlights


- The UPR Pre-School Development Center (CDP, for its Spanish acronym) and the Child Development Center continued offering services, as interdisciplinary practice laboratories; and implementing an inclusion model in early intervention with a family centered model of service; its services were evaluated with 90.5% and 100% satisfaction respectively.
- The Puerto Rico Family to Family Center continued offering services by providing peer-to-peer support to more than 200 families and training over 1,900 professionals, families and people with disabilities.
- The PR-UCEDD received funds through the AUCD and ACL to work in promoting accessibility to COVID vaccination for people with DID.
- An accessible COVID vaccination event was organized for people with disabilities sponsored by the MSC Vaccination Clinic.
